# **Anti-Counterfeit**

#### For the Government

- Enhance governmental presence
- Protect public health and personal security
- Collect legal taxes use for public well being
- Block false identification of humans and property

#### For the people

- Get what you pay for

## **Protecting Expiration Date**

- Extending products' expiration date is a common practice of importers and distribution chains, unwilling to dispose outdated products
- Such an activity results in improper sensitive goods being consumed by the public (usually foods, beverages and medicines)
- The public is unprotected
- Counter-Fight provides an absolute protection, in maintaining the original expiration date



## **Brand Protection**

- Brand names make a substantial share of the business value
- Should your brand name be breached, customers will prefer your competitors' products, removing counterfeit doubts
- Gaining back your customers' trust is an expensive and time consuming effort



### **Stolen Products Detection**

- Counter-Fight provides every package with a unique ID ('Proof-of-DNA')
- As Counter-Fight data is encrypted, it is the ONLY system to enable using consecutive serial numbers of your products
- Should a criminal activity occur (Stolen truck, Warehouse burglary...) the stolen goods, which are marked in advance in the production line, are individually recognized
- Any authentication event (whatever reason) will put the Counter-Fight server in contact with the stolen product holder (an innocent person)
- Offering the holder a personal gift, will result in obtaining the point of sale: where did the customer buy the product
- The route to the thieves was never shorter...



# **Grey Market Prevention**

- International distributed products are sold to different countries charging different prices (based on customers payment abilities)
- Substantial price difference tempts fraudulent activities of channeling shipments from their original country to another market
- International manufacturers can easily detect grey market activities, using Counter-Fight (destination code is embedded in Counter-Fight)



### **Authenticating Device Location**

- In the authentication process, the calling device provides its IP and GPS coordinates
- The system owner can trace the country and exact location of the calling device
- Refer to the offered demonstration of slide #2 to follow the location process
- The presented coordinates (Latitude & Longitude) can be translated to the exact address.
